We are committed to:

- Delivering at least a 10% net gain in biodiversity through all new planning applications in England from January 2024 in line with the requirements of the Environment Act 2021.
- Using our experience in England to develop a biodiversity target for our sites in Scotland.
- Developing a strategy for biodiversity that permeates our business, including supply chain, operations, design, and strategic land.
- Delivering at least one integrated measure for nature per plot through all new planning applications from September 2024, and monitoring the success of those measures
- Developing KPIs for measuring our progress on supporting nature

Our Approach

- We are committed to following the hierarchy of mitigation to minimise losses of existing biodiversity in our development designs.
- Ecology expertise is deployed on all development sites to assess risks and to manage impacts in line with legislation and best practice.
- We will always seek to deliver biodiversity gains through on-site enhancements in the first instance. This supports our goals of creating climate resilient, sustainable developments with easy access to nature for all.
- Where offsite nature gains are required, we will seek to identify the best possible locations to maximise benefits.
- We will continue to explore how adaptation for climate change can support biodiversity.
- We are committed to ensuring that we can increasingly recognise and mitigate risks to nature within our supply chain.
- We will work with contractors who will secure the benefits of our biodiversity improvements into the future.
